- 2. Application Incomplete and/or mislead information provided shall not be considered. In view of candidate's privacy, Candidates' information provided shall have limited access by Secretariat staff and the Race Official Committee of the HKCDBA for purpose of course enrolment process.
- 3. Any doubts on information provided by applicants, HKCDBA reserves all right to enquire applicants on appropriate certifications. Fail to produce certifications in relate to matters abovementioned, right of refusal in participation shall be maintained. All fees paid shall not be refunded HKCDBA reserves.

- 9. If typhoon signal 3 or above, red or black rainstorm signal hoisted 2 hours prior to date of course, session of the say shall be cancelled, date of make-up class depends on venue arrangement. If Thunderstorm warning, amber rainstorm or Typhoon signal no.1 hosted, candidates are required to report at venue. Course shall be determined by instructor whether proceed or cancelation.
